
- Managing partner in Green & Sklarz LLC, a boutique tax firm with offices in Connecticut and New York.





What is "PCI Compliance"?

Payment card industry (PCI) compliance is mandated by credit card companies to help ensure the security of credit card transactions in the payments industry. Payment card industry compliance refers to the technical and operational standards that businesses follow to secure and protect credit card data provided by cardholders and transmitted through card processing transactions.

Why does the IRS care about this?

The IRS instituted IRC § 6050W requiring tax professionals to comply with PCI requirements.

Under new section 6050W, any payment settlement entity making payment to a participating payee in settlement of reportable payment transactions must make a return for each calendar year to be filed with the Service, and furnish a statement to the participating payee, setting forth the gross amount of such reportable payment transactions, as well as the name, address, and taxpayer identification number (TIN) of the participating payees.






