




Step #2: Everything starts with the tax organizer

- Its how we are certain we gather the client's information
- It reminds them of what they had reported previously
- It helps us meet our ethical standards
 - 1. AICPA Standards for Tax Services: Section 1.1.6 due diligence
 - 2. Circular 230: Section 10.22 Diligence as to Accuracy



Are you using Organizers?







There are a number of reasons to use organizers

- Proving what was uploaded and not
- Virtual currency and Foreign Assets question
- Automation to remove data entry errors (#1 reason for bad audits)
- Save time



Proving what was filed

- "I know I gave you that 1099," says the client with conviction
- Rule: they owe the tax and interest, you are responsible for the penalties
- CT Senator introduced a bill and tried to make the preparer responsible for everything (tax interest and penalties it failed)





By automating the organizer

- It will show what was uploaded
- It will show when it was uploaded
- Items will get picked up automatically for the 1040 preparation
- Tax Rep Members: Saved 65% of prep time by automating this process!





So two IRS guys walk into a bar

- Start discussing using all the data
- FATCA, John Doe Summonses, etc
- Scratch out on a cocktail napkin the use of data in IRS collections
- 2022 Collection cases referred to Criminal Investigation went up 42%





Virtual Currency / Foreign Assets



- Clients MUST answer these questions
- Automated organizer requires a response
- It is your get out of jail/malpractice card
- Major IRS priority and subject to data matching



Automating the organizer and the return process





But MY clients don't want to do this..

- You can drop your documents off, all stapled that need to be separated and scanned
- But we are not Kinkos or Staples
- "We will need to charge an additional \$150 for our staff time doing this for you,"
- I find that cures the client's laziness



Automate the 1040 Preparation



- Gruntworx will automate the 1040 preparation (mostly)
- Human's always need to review
- Eliminates transposition errors and got back TRN members 65% of the time usually spent on prep
- More time (Dawn) or more clients (Felecia)?



Reasonable Comp

- IRS hit target now we use RCReports
- Does your 1120, 1120-S or 990 clients have a report to support the wages being claimed?
- ▶ This is NOT part of the 1120 or 990 prep it's a cost the client needs to bear
- Blame the IRS.....
- Create a whole new revenue stream
- Profitable LLCs? Maybe its time to convert to an S Corp (until 3/15/25)



Get 8821s and Set-Up Tax Help Software

- The 8821 allows you to pull information but not be on record for representation
- Allows you to identify First Time Abatement opportunities (can take as a 30% contingent fee)
- Allows for transcript monitoring
